SELECTING THE VOTES

The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the "gold standard" and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America's federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.

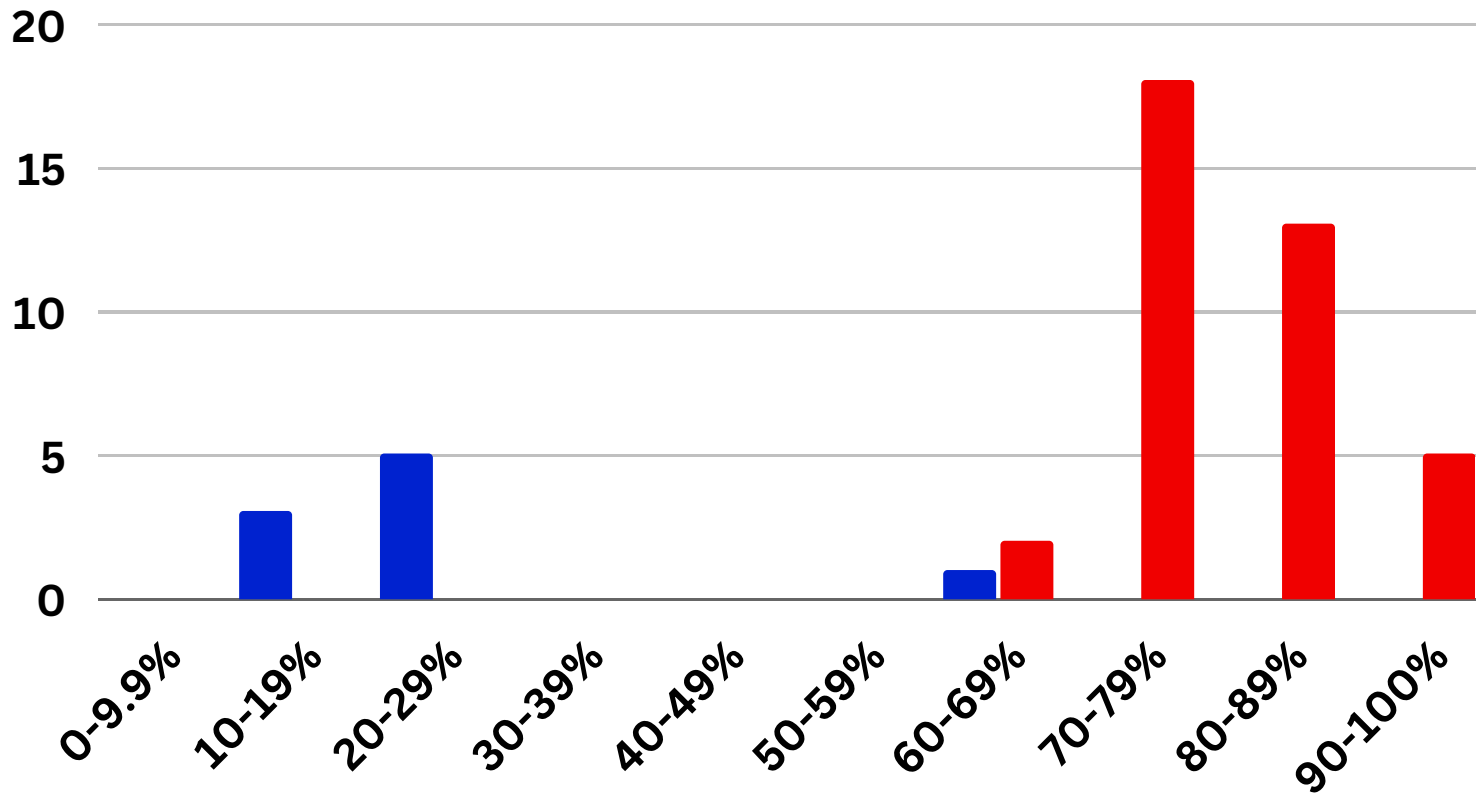

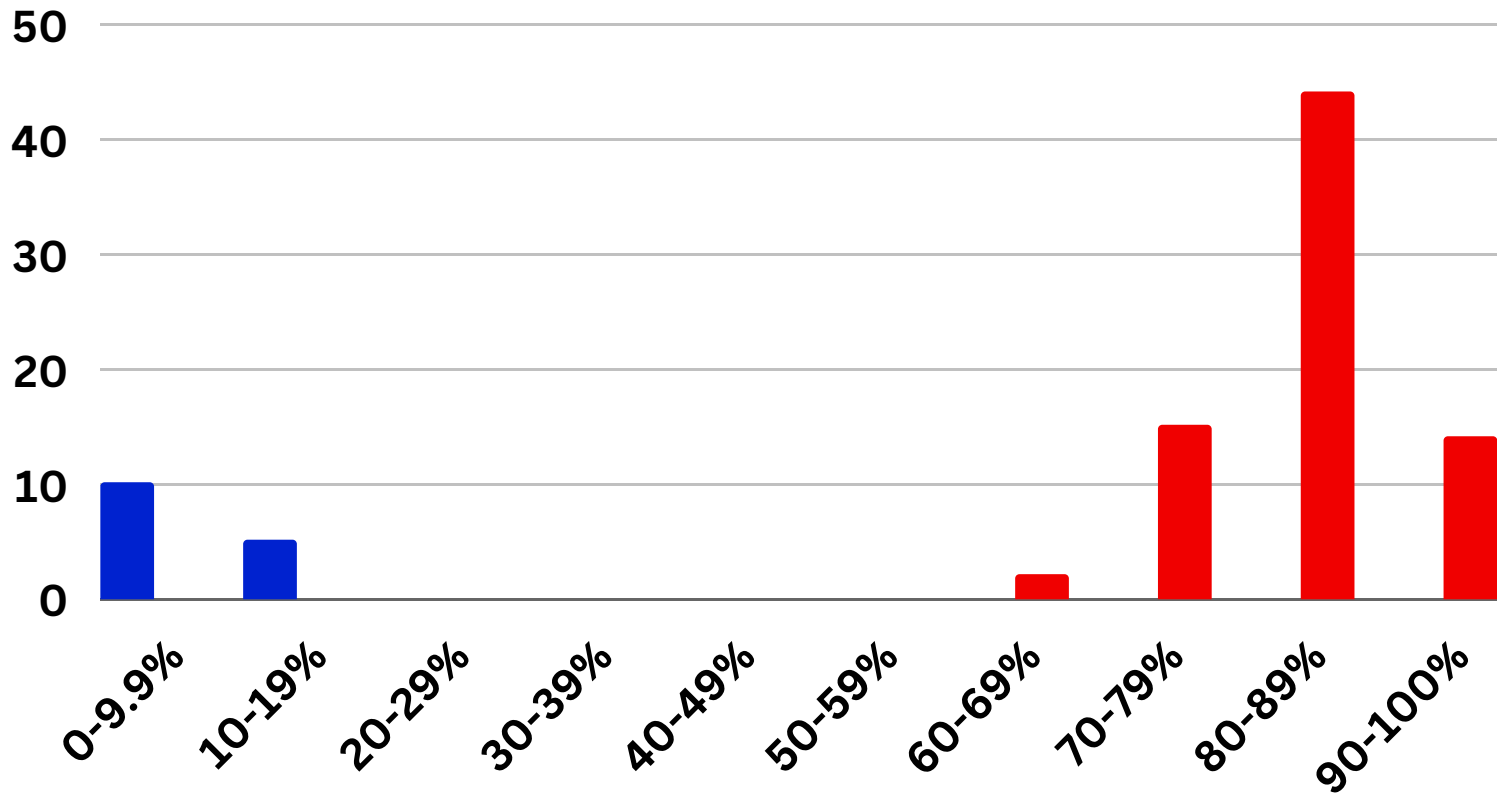

HB 2034 Protecting the State Pension System from Woke Political Agendas.

This bill restricts the investment of Oklahoma pension funds by firms that adopt strategies akin to Environmental Social Governance (ESG). CPAC supports protecting taxpayers from lower performing pension guidance, opposes the weaponization of publicly held funds to pursue woke political aims and supported this bill. The Senate passed the bill on April 26, 2022 by a vote of 38-3 and the bill was signed into law.

HB 2974 Cleaning the Voting Rolls.

This bill requires the state election board with the assistance of district attorneys to investigate instances in which ten or more voters are found to be registered at a single residential address. CPAC supports efforts to fight election fraud, supports the investigation of abnormalities that may arise during the election process, and supported this bill as a step in the right direction. The Senate passed the bill on April 26, 2022 by a vote of 34-9 and the bill later became law.

HB 3046 Banning Zuckerbucks.

This bill, known as the Prohibit the Private Funding of Elections Act, forbids elections officials from accepting private funds for the purpose of administering an election. CPAC supports efforts to curb the influence of outside groups on the election process and supported this bill. The Senate passed the bill on April 27, 2022 by a vote of 37-9 and the bill later became law.

HB 3081 Tax Credits for Favored Businesses.

This bill creates the Strategic Industrial Development Tax Credit for government-favored businesses. CPAC supports tax relief but opposes carve-outs that leave other ineligible businesses at a disadvantage and opposed this bill. The Senate passed the bill on April 27, 2022 by a vote of 26-17 and the bill later became law.

HB 3144 Protecting Firearm Companies from Discrimination.

This bill makes it such that the government can't enter into contracts with companies that discriminate against firearm associations and entities. This discourages banks from wrongly cutting off the firearms industry from capital and the free market at large. CPAC believes that all legal entities are entitled to participate in the free market, supports efforts to protect Second Amendment rights, and supported this bill. The Senate passed the bill on April 27, 2022 by a vote of 37-8 but the bill was never given final approval.



HB 3232 Strengthening Local Control of Elections.

This bill states that, in the event that a federal law is passed that substantially modifies or changes election law, such a law will only be applied to federal elections. CPAC supports efforts to improve state control over the election process and supported this bill. The Senate passed the bill on April 19, 2022 by a vote of 33-7 but the bill did not receive final approval.

HB 3316 Reducing Barriers to Employment for the Formerly Incarcerated.

This bill makes it such that, under certain circumstances, criminals may become eligible to have their records automatically sealed (expunged). CPAC Foundation's Nolan Center for Justice is a national leader in criminal justice reform and works to cut crime, reduce taxpayer costs, protect victims, define the proper scope of government and responsibly reduce incarceration rates. CPAC supports helping non-violent offenders attain gainful employment and supported this bill. The Senate passed the bill on April 27, 2022 by a vote of 42-1 and the bill later became law.

HB 3364 Increasing Election Integrity by Strengthening Absentee Voting Provisions.

This bill requires that all those applying for an absentee ballot provide their name, birth date, an identification number, and their address in their application. It also requires that this information be checked in order to see if it matches the information about the voter in their voter registration record. CPAC supports appropriate election reforms and supported this bill. The Senate passed the bill on April 27, 2022 by a vote of 37-8 and the bill later became law.

HB 4085 Giving Special Tax Carveouts to Select Businesses.

This bill, known as the Oklahoma Rural Jobs Act, gives tax credits to qualifying businesses that invest a certain amount of money in rural areas of the states. Although CPAC supports tax relief whenever possible, it opposes carveouts for government favored businesses and opposed this bill. The Senate passed the bill on May 20, 2022 by a vote of 36-7 and the bill later became law.

HB 4327 Protecting Life by Allowing Civil Action Against Those Who Aid and Abet Abortion Procedures.

This bill allows private individuals to bring civil actions against those who knowingly perform or attempt to perform abortion procedures save under a few circumstances. State entities are not allowed to enforce this law. CPAC believes abortion is always a tragedy and supported this bill. The Senate passed the bill on April 28, 2022 by a vote of 35-10 and the bill later became law.



HB 4455 Massive \$698,020,000 Corporate Welfare Incentive Program.

This bill, known as the LEAD Act, creates an investment rebate program until 2032 for qualified companies looking to move to Oklahoma. It specifies that such companies must create a certain amount of jobs and invest a particular amount of money in order to qualify. HB 4454 appropriates \$698,020,000 to this endeavor. CPAC strongly opposes this extravagant corporate welfare and opposed this bill. The Senate passed this bill on April 21, 2022 by a vote of 41-5 and the bill later became law.

SB 2 Preserving Women's Sports.

This bill, known as the Save Women's Sports Act, requires school to either divide sports teams by biological sex or designate them as coed. Males are prohibited from playing on teams designated for females. CPAC supports creating a safe and fair environment of play in school sports teams and supported this bill. The Senate passed the bill on March 24, 2022 by a vote of 37-7 and the bill later became law.

SB 523 Preventing Election Law Changes Not Authorized by the Legislature. .

This bill prohibits entities affiliated with the state from entering into "settlements" or legal agreements that alter election law procedures prescribed by the legislature. CPAC supports this effort to prevent ballot security changes that have occurred through these agreements and supported this bill. The Senate passed the bill on May 16, 2022 by a vote of 35-8 and the bill later became law.

SB 615 Protecting Privacy in School Restrooms.

This bill requires grade schools to designate multiple occupancy restrooms as being exclusively for members of the female or male sex. CPAC supports efforts to improve privacy in restrooms and supported this bill. The Senate passed the bill on May 19, 2022 by a vote of 38-7 and the bill later became law.

SB 1352 Preserving Consumer Choice in Energy.

This bill, known as the Oklahoma Consumer Energy Choice Act, prevents local governments from restricting access to certain fuels and power sources. CPAC supports all forms of energy, believes government should not support one form of energy over another and supported this bill. The Senate voted to pass the bill on March 24, 2022 by a vote of 38-6 and the bill later became law.

OKLAHOMA SENATE VOTE DESCRIPTIONS

SB 1555 Protecting Life.

This bill, in the event that the Supreme Court overturns *Roe v. Wade*, triggers laws banning abortions under most circumstances. CPAC believes abortion is always a tragedy and supported this bill. The Senate passed the bill on March 10, 2022 by a vote of 34-9 and the bill later became law.

SB 1646 Establishing a Felony Classification System.

This bill establishes a system by which differing felony crimes can be classified into categories and assigned punishments accordingly. Oklahoma is one of 8 states that lacks such a system. This bill would have provided a framework for more predictable and consistent sentencing. CPAC's Nolan Center for Justice Reform is a national leader in conservative solutions to the justice system and works to cut crime, reduce taxpayer costs, protect victims, define the proper scope of government, and safely reduce incarceration rates. CPAC supports establishing a system that appropriately holds people accountable while reducing wasteful government spending and supported this bill. The Senate passed this bill on March 23, 2022 by a vote of 35-12 but the bill did not progress in the House.

SB 1647 School Choice Through Education Savings Accounts.

This bill, known as the Oklahoma Empowerment Act, sets up Oklahoma Empowerment Accounts, a variation on education accounts that allow parents to choose better schools for their children. CPAC has long supported this form of school choice and supported this bill. The Senate defeated the bill on March 23, 2022 by a vote of 22-24.

SB 1857 Tax Credits for 'Green' Vehicles.

This bill extends tax credits to the purchase of 'clean burning' vehicles and hydrogen fuel cells. CPAC opposes the subsidized displacement of gas-powered vehicles, believes government should not support one form of energy over another, and opposed this bill. The Senate passed this bill on May 20, 2022 by a vote of 33-11 and the bill later became law.

HJR 1048 Requiring Valid ID for Voting.

This joint resolution proposes a constitutional amendment that would make the presentation of a valid ID by an elector to an authorized official a requirement for voting. CPAC supports requirements that an ID be presented by an elector in order for them to vote and supported this resolution. The House passed the resolution on March 22, 2022 by a vote of 77-19 but the resolution was not taken up by the Senate.

HJR 1058 Upping the Requirement for Constitutional Amendments.

This joint resolution requires that, when attempting to approve an amendment, at least 55 percent of electors who cast their ballot support the amendment in order for it to pass, an increase over the simple majority that was originally required to pass the amendment. CPAC supports this increase in the threshold required to pass an amendment because it better mimics rules at the federal level, the likes of which require large majorities to pass constitutional amendments. The House passed this resolution on March 22, 2022 by a vote of 74-21 but the resolution was not taken up by the Senate.

HB 2034 Protecting the State Pension System from Woke Political Agendas.

This bill restricts investment into Oklahoma pension funds by firms that adopt Environmental Social Governance-adjacent (ESG) strategies. CPAC supports protecting taxpayers from lower performing pension guidance, opposes the weaponization of publicly held funds to pursue woke political aims and supported this bill. The House passed the bill on May 4, 2022 by a vote of 60-14 and the bill was signed into law.

HB 2974 Cleaning the Voting Rolls.

This bill requires the state election board with the assistance of district attorneys to investigate instances in which ten or more voters are found to be registered at a single residential address. CPAC supports efforts to fight election fraud, supports the investigation of abnormalities that may arise during the election process, and supported this bill as a step in the right direction. The House passed the bill on May 4, 2022 by a vote of 61-10 and the bill later became law.

HB 2984 Blocking a Federal Ban on Firearms.

This bill forbids peace officers and all other political subdivisions of the state from enforcing any federal ban on firearms, accessories, or ammunition. CPAC supports our founder's belief in the Second Amendment and supported this bill. The House passed the bill on March 7, 2022 by a vote of 78-15 but the bill was not taken up by the Senate.



HB 3046 Banning Zuckerbucks.

This bill, known as the Prohibit the Private Funding of Elections Act, forbids elections officials from accepting private funds for the purpose of administering an election. CPAC supports efforts to curb the influence of outside groups on the election process and supported this bill. The House passed the bill on March 9, 2022 by a vote of 79-18 and the bill later became law.

HB 3069 Allowing Local Officials to Carry Concealed Firearms.

This bill authorizes municipalities to allow certain local officials and employees, under some conditions, to carry concealed firearms. CPAC supports our founder's belief in the Second Amendment and supported this bill. The House passed the bill on March 7, 2022 by a vote of 80-13 but the bill did not get a final vote in the Senate.

HB 3081 Tax Credits for Favored Businesses.

This bill creates the Strategic Industrial Development Tax Credit for government-favored businesses. CPAC supports tax relief but opposes carve-outs that leave other ineligible businesses at a disadvantage and opposed this bill. The House passed the bill on May 20, 2022 by a vote of 62-14 and the bill later became law.

HB 3144 Protecting Firearms Companies from Discrimination.

This bill makes it such that the government can't enter into contracts with companies that discriminate against firearm associations and entities. This discourages banks from wrongly cutting off the firearms industry from capital and the free market at large. CPAC believes that all legal entities are entitled to participate in the free market, supports efforts to protect Second Amendment rights, and supported this bill. The House passed the bill on May 17, 2022 by a vote of 73-18 but the bill did not get a final vote.

HB 3157 Restricting Municipal Control of Firearms.

This bill removes the ability of municipalities to regulate the carrying of firearms by those it governs. CPAC supports efforts to protect Second Amendment rights and supported this bill. The House passed the bill on March 8, 2022 by a vote of 79-17 but the bill was not taken up by the Senate.



HB 3232 Strengthening Local Control of Elections.

This bill states that, in the event that a federal law is passed that substantially modifies or changes election law, such a law will only be applied to federal elections. CPAC supports efforts to improve state control over the election process and supported this bill. The House passed the bill on May 17, 2022 by a vote of 74-12 but the bill did not receive final approval.

HB 3280 Limiting Government Owned Land.

This bill limits the amount of public land that may be owned by the state of Oklahoma, its agencies, and the federal government to no more than 10% of the total land in the state. CPAC believes the government owns far too much land and supported this bill. The House passed the bill on March 24, 2022 by a vote of 51-40 but the bill was not taken up in the Senate.

HB 3316 Reducing Barriers to Employment for the Formerly Incarcerated.

This bill makes it such that, under certain circumstances, criminals may become eligible to have their records automatically sealed (expunged). The Nolan Center for Justice is a national leader in criminal justice reform and works to cut crime, reduce taxpayer costs, protect victims, define the proper scope of government and responsibly reduce incarceration rates. CPAC supports helping non-violent offenders attain gainful employment and supported this bill. The House passed the bill on March 9, 2022 by a vote of 87-4 and the bill later became law.

HB 3364 Increasing Election Integrity by Strengthening Absentee Voting Provisions.

This bill requires that all those applying for an absentee ballot provide their name, birth date, an identification number, and their address in their application. It also requires that this information be checked in order to see if it matches the information about the voter in their voter registration record. CPAC supports appropriate election reforms and supported this bill. The House passed the bill on May 16, 2022 by a vote of 75-16 and the bill later became law.

HB 3635 Tax Relief.

This bill increases the standard deduction for personal income taxes and creates provisions to reduce the income tax rate by .5% each year if certain conditions are met. CPAC supports tax reforms that are enacted across the board and supported this bill. The House passed the bill on March 23, 2022 by a vote of 73-19 but this version of the bill was not taken up by the Senate.



HB 4085 Giving Special Tax Carveouts to Select Businesses.

This bill, known as the Oklahoma Rural Jobs Act, gives tax credits to qualifying businesses that invest a certain amount of money in rural areas of the states. Although CPAC supports tax relief whenever possible, it opposes carveouts for government favored businesses and opposed this bill. The House passed the bill on May 20, 2022 by a vote of 67-6 and the bill later became law.

HB 4327 Protecting Life by Allowing Civil Action Against Those Who Aid and Abet Abortion Procedures.

This bill allows private individuals to bring civil actions against those who knowingly perform or attempt to perform abortion procedures save under a few circumstances. State entities are not allowed to enforce this law. CPAC believes abortion is always a tragedy and supported this bill. The House passed the bill on May 19, 2022 by a vote of 73-16 and the bill later became law.

HB 4455 Massive \$698,020,000 Corporate Welfare Incentive Program.

This bill, known as the LEAD Act, creates an investment rebate program with an end date of 2032 for qualified companies looking to move to Oklahoma. It specifies that such companies must create a certain amount of jobs and invest a particular amount of money in order to qualify. HB 4454 appropriates \$698,020,000 to this endeavor. CPAC strongly opposes this extravagant corporate welfare and opposed this bill. The House passed this bill on April 19, 2022 by a vote of 81-17 and the bill later became law.

SB 523 Preventing Election Law Changes Not Authorized by the Legislature.

This bill prohibits entities affiliated with the state from entering into “settlements” or legal agreements that alter election law procedures prescribed by the legislature. CPAC supports this effort to prevent ballot security changes that have occurred through these agreements and supported this bill. The House passed the bill on April 27, 2022 by a vote of 71-12 and the bill later became law.



SB 615 Protecting Privacy in School Restrooms.

This bill requires grade schools to designate multiple occupancy restrooms as being exclusively for members of the female or male sex. CPAC supports efforts to improve privacy in restrooms and supported this bill. The House passed the bill on May 19, 2022 by a vote of 69-14 and the bill later became law.

SB 1352 Preserving Consumer Choice in Energy.

This bill, known as the Oklahoma Consumer Energy Choice Act, prevents local governments from restricting access to certain fuels and power sources. CPAC supports all forms of energy, believes government should not support one form of energy over another and supported this bill. The House passed the bill on April 19, 2022 by a vote of 77-5 and the bill later became law.

SB 1555 Protecting Life.

This bill, in the event that the Supreme Court overturns *Roe v. Wade*, triggers laws banning abortions under most circumstances. CPAC believes abortion is always a tragedy and supported this bill. The House passed the bill on April 26, 2022 by a vote of 77-14 and the bill later became law.

SB 1857 Tax Credits for 'Green' Vehicles.

This bill extends tax credits to the purchase of 'clean burning' vehicles and hydrogen fuel cells. CPAC opposes the subsidized displacement of gas-powered vehicles, believes government should not support one form of energy over another, and opposed this bill. The House passed the bill on May 20, 2022 by a vote of 70-10 and the bill later became law.
