SELECTING THE VOTES

The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the "gold standard" and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America's federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.





HB 118 Protecting the Dignity of Fetal Remains.

This bill requires healthcare facilities that possess fetal remains to properly dispose of such remains. CPAC believes that the unborn should be treated with the same dignity and respect as one already born and supported this bill. The Senate passed this bill on June 29, 2022 by a vote of 29-21 but the bill did not get final approval.

HB 972 Protecting Women's Sports.

This bill requires public schools to designate sports teams as being for males, females, or both (coed). It then prohibits public schools from allowing males to play on teams designated as being for females. CPAC supports efforts to create a safe and fair environment of play in school sports and supported this bill. The Senate passed the bill on June 29, 2022 by a vote of 30-20 but the bill was vetoed by the governor.

HB 1059 Targeted Tax Breaks.

This tax bill creates a new program, known as the Pennsylvania Development for a Growing Economy program or "PA Edge," that provides around \$2 billion in tax incentives to businesses in government-favored industries. CPAC supports appropriate tax relief whenever possible but opposes programs that selectively favor some companies over others and opposed this bill. The Senate passed the bill on October 26, 2022 by a vote of 41-8 and the bill later became law.

HB 1500 Prohibiting Discriminatory Abortions.

This bill prohibits physicians from performing an abortion if the woman seeking the abortion desires such because her unborn baby has been diagnosed with Down Syndrome. CPAC believes abortion is always a human tragedy, supports restrictions on the practice, and supported this bill. The Senate voted to remove this bill from the table on June 30, 2022 by a vote of 29-21 but the bill failed to progress further.

HB 2210 Infringing on Property Rights.

This bill adds land banks to the list of properties that the government can take into conservatorship if they are deemed "blighted." CPAC opposes increasing the list of lands that can be taken into conservatorship and opposed this bill. The Senate passed the bill on October 24, 2022 by a vote of 42-6 and the bill later became law.





HB 2398 Deregulating Advanced Technology.

This bill allows for the testing of autonomous vehicles without a human operator present. CPAC supports appropriate efforts to advance technology through deregulation and supported this bill. The Senate passed the bill on October 26, 2022 by a vote of 29-20 and the bill later became law.

SB 106 Clarifying That There is No "Right" to Abortion.

This bill proposes a constitutional amendment that would state that there exists no constitutional right to a taxpayer-funded abortion or any other right to abortion. CPAC believes abortion is always a human tragedy and supported this proposed amendment. The Senate passed the resolution on July 8, 2022 by a vote of 28-22 but the resolution must still pass in two consecutive legislative sessions in order to be placed on the ballot.

SB 573 Strengthening the Power of Poll Watchers.

This election reform bill increases the number of poll watchers that must be present at an election and allows poll watchers to be inside polling places. It also increases penalties for those who do not permit overseers and watchers to be present while ballots are being counted. CPAC supports efforts to reduce election fraud and supported this bill. The Senate passed the bill on June 6, 2022 by a vote of 30-19 but the bill was vetoed by the governor.

SB 771 Large Corporate Tax Cut.

This bill reduces the corporate net income tax rate from 9.99% to 5.99% at a rate of 1% per year if revenue projections are met. CPAC supports broad, pro-growth tax relief and supported this bill. The Senate passed the bill on June 15, 2021 by a vote of 31-19 but the bill was not taken up in the House.

SB 982 (PN 1264) Banning Zuckerbucks.

This early version of SB 982 prohibits private groups from assisting in paying the costs associated with administering elections or registering voters for the election. CPAC supports efforts to preserve ballot integrity and supported this bill as a step in the right direction. The Senate passed this version of the bill on April 13, 2022 by a vote of 37-12.





SB 1191 Attempt to Protect Women's Sports.

This bill requires public schools to designate sports teams as being for males, females, or both (coed). It then prohibits public schools from allowing males to play on teams designated as being for females. CPAC supports efforts to create a safe and fair environment of play in school sports and supported this bill. The Senate passed the bill on June 6, 2022 by a vote of 30-20 but the bill was not brought up in the House.

SB 1200 Securing the Absentee Ballot.

This bill refines a series of steps that must be taken before an absentee ballot is counted. For example, it requires that absentee ballots be delivered to an employee at the primary office of the county board of elections. CPAC strongly supports absentee ballot reform and supported this bill. The Senate passed the bill on April 13, 2022 by a vote of 29-20 but the bill was not taken up in the House.

SB 1277 Strengthening Parental Rights.

This bill requires that schools notify parents of any curricula or books present in the school that contain sexually explicit content. CPAC supports efforts to allow parents to know what their child is being taught and supported this bill. The Senate passed the bill on June 29, 2022 by a vote of 30-20 but the bill was not taken up in the House.

SB 1278 Helping Parents Learn More About their Child's Well-Being.

This bill prohibits schools from withholding vital information related to the health and well-being of their child. CPAC strongly supports efforts to prevent schools from withholding student health information from parents and supported this bill. The Senate passed the bill on June 29, 2022 by a vote of 29-21 but the bill was not taken up in the House.

HB 71 Putting Restraints on Runaway Spending.

This bill proposes a constitutional amendment that would put restraints on government spending, capping the amount of money that may be spent by the state government at a sum equivalent to that spent during the prior year plus a particular sum calculated based on population growth and inflation. CPAC supports efforts to restrain wild government spending and supported this bill. The House voted against discharging the bill on June 21, 2022 by a vote of 89-111 but the bill did not progress beyond the House.

HR 187 Criticizing the War Against Pipelines.

This resolution calls on the governors of New York and New Jersey to end anti-pipeline policies that prevent the construction of new natural gas pipelines. CPAC supports all forms of energy, opposes New York and New Jersey's discrimination against natural gas, and supported this resolution. The House passed the resolution on March 30, 2022 by a vote of 134-64.

HB 398 Strengthening Parental Responsibility.

This bill requires custodial parents seeking government medical assistance for a child to cooperate with the state in also seeking help from the noncustodial parent. CPAC supports efforts to strengthen parental responsibility concerning the medical needs of a child and supported this bill. The House passed the bill on May 24, 2022 by a vote of 113-90 but the bill was not taken up in the Senate.

HB 604 Streamlining Government Permits.

This bill ensures that the acquisition of a construction permit from the Department of Environmental Protection occurs in a timely manner. CPAC has long supported reforms that lessen the burdensome nature of government permits and supported this bill. The House passed the bill on April 11, 2022 by a vote of 115-85 but the bill was not taken up in the Senate.

HB 637 Giving the General Assembly Control over Carbon Taxes.

This bill requires the Department of Environmental Protection of the Commonwealth to receive approval from the General Assembly first prior to joining a greenhouse gas cap-and-trade program. It also reserves the power to levy a tax on carbon dioxide emissions to the General Assembly. CPAC supports efforts to improve legislative power over that of bureaucratic agencies and supported this bill. The House passed the bill on March 30, 2022 by a vote of 126-72 but the bill was not taken up in the Senate.





HB 972 Protecting Women's Sports.

This bill requires public schools to designate sports teams as being for males, females, or both (coed). It then prohibits public schools from allowing males to play on teams designated as being for females. CPAC supports efforts to create a safe and fair environment of play in school sports and supported this bill. The House passed the bill on April 12, 2022 by a vote of 115-84 but the bill was vetoed by the governor.

HB 1059 Targeted Tax Breaks.

This tax bill creates a new program, known as the Pennsylvania Development for a Growing Economy program or "PA Edge," that provides \$2.1 billion in tax incentives to businesses in government-favored industries. CPAC supports appropriate tax relief whenever possible but opposes programs that selectively favor some companies over others and opposed this bill. The House passed the bill on October 26, 2022 by a vote of 139-59 and the bill later became law.

HB 1161 Attempting to Steer the Energy Industry.

This bill incentivizes the construction of local solar facilities within the state and establishes a program that will allow low-income energy consumers to choose to use more expensive solar-generated electricity while remaining in a customer assistance program. CPAC supports all forms of energy, does not believe that the government should incentivize the use or generation of one form of energy over another, and opposed this bill. The House passed the bill on June 14, 2022 by a vote of 167–33 but the bill was not taken up in the Senate.

HB 2210 Infringing on Property Rights.

This bill adds land banks to the list of properties that the government can take into conservatorship if they are deemed "blighted." CPAC opposes increasing the list of lands that can be taken into conservatorship and opposed this bill. The House passed the bill on April 26, 2022 by a vote of 174-29 and the bill later became law.

HB 2398 Deregulating Advanced Technology.

This bill allows for the testing of autonomous vehicles without a human operator present. CPAC supports appropriate efforts to advance technology through deregulation and supported this bill. The House passed the bill on October 26, 2022 by a vote of 119-79 and the bill later became law.





HB 2461 Paving a Way Toward Energy Independence.

This bill sets up a means of approving applications to drill for oil and gas beneath state forest and park property. CPAC supports all forms of energy, supports maintaining America's energy independence, and supported this bill. The House passed the bill on April 11. 2022 by a vote of 116-84 but the bill was not taken up by the Senate.

SB 106 Clarifying That There is No "Right" to Abortion.

This bill proposes a constitutional amendment that would state that there exists no constitutional right to a taxpayer-funded abortion or any other right to abortion. CPAC believes abortion is always a human tragedy and supported this proposed amendment. The House passed the resolution by a vote of 107-92 but the resolution has to pass in two consecutive legislative sessions in order to be placed on the ballot.

SB 119 Requiring Legislative Approval for a Carbon Tax.

This bill requires the Department of Environmental Protection to receive public comment and submit to the General Assembly any proposals to install a revenue-generating tax (e.g. a carbon tax). CPAC supports appropriate efforts to reduce bureaucratic discretion and supported this bill. The House defeated the bill on March 30, 2022 by a vote of 82-116.

SB 275 Cracking Down on Municipal Overreach.

This bill prevents local governments from restricting the form of energy that individual consumers can receive from utilities. CPAC supports all forms of energy, believes that the government should not support one form of energy over another, and supported this bill. The House passed the bill on July 6, 2022 by a vote of 117-83 but the bill was vetoed by the governor.

SB 349 (Amd. 4028) Raising the Tax Burden on Businesses.

This amendment to SB 349 makes unfavorable changes to the manner in which a business may treat its property as a deductible expense, removing a provision that would allow the property to be treated as a deductible expense to the extent allowable under the version of Section 179 in place at the time the property was purchased. CPAC believes that this is an unfair means of constructing the tax scheme and opposed this amendment. The House defeated the amendment on April 25, 2022 by a vote of 88-112.





SB 573 Strengthening the Power of Poll Watchers.

This election reform bill increases the number of poll watchers that must be present at an election and allows poll watchers to be inside polling places. It also increases penalties for those who do not permit overseers and watchers to be present while ballots are being counted. CPAC supports efforts to reduce election fraud and supported this bill. The House passed the bill on June 28, 2022 by a vote of 111-89 but the bill was vetoed by the governor.

SB 982 (PN 1855) Banning Zuckerbucks.

This early version of SB 982 prohibits private groups from assisting in paying the costs associated with administering elections or registering voters for the election. CPAC supports efforts to preserve ballot integrity and supported this bill as a step in the right direction. The House passed this version of the bill on July 7, 2022 by a vote of 110-90.
