SELECTING THE VOTES

The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the “gold standard” and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America’s federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.

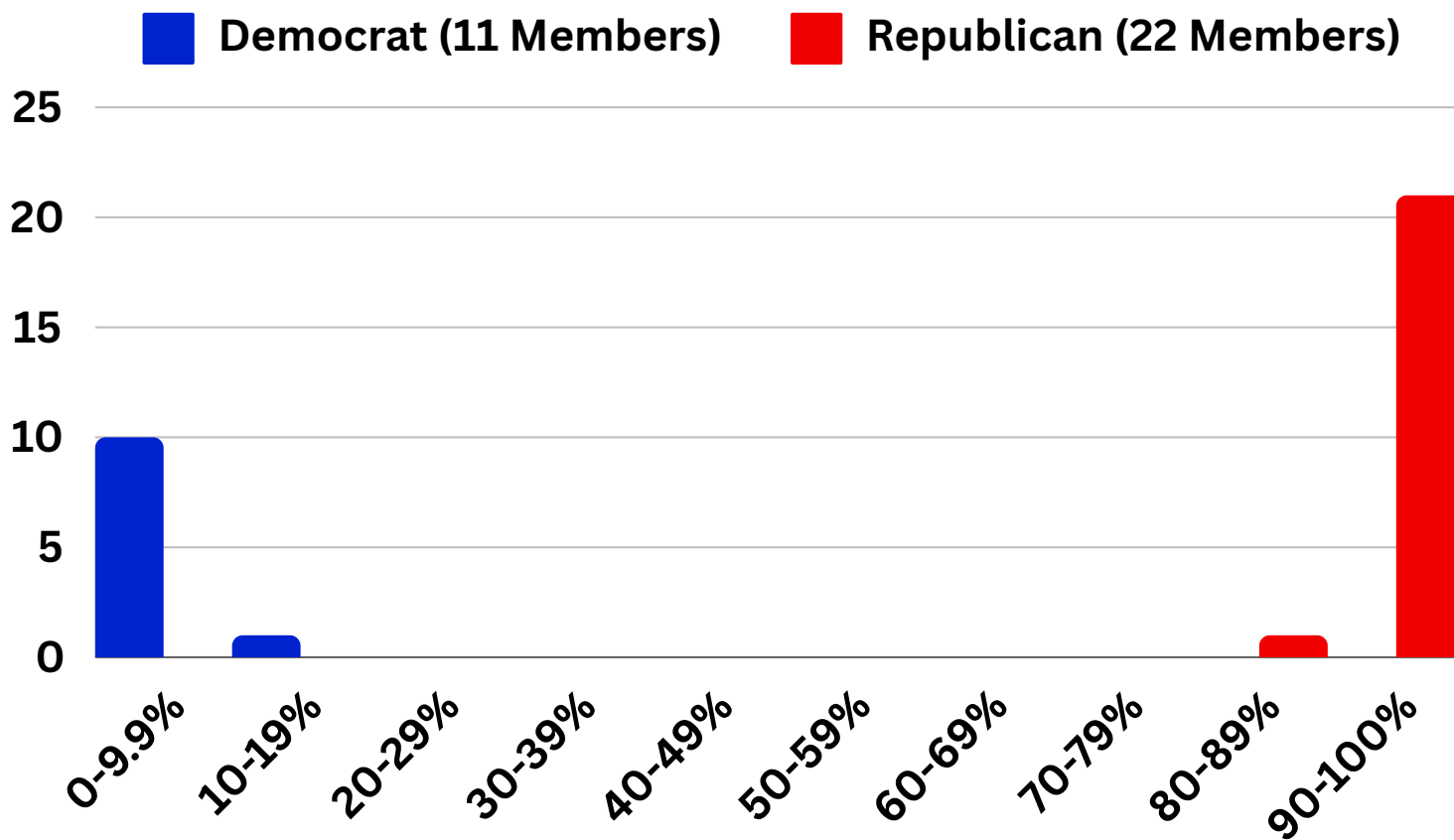

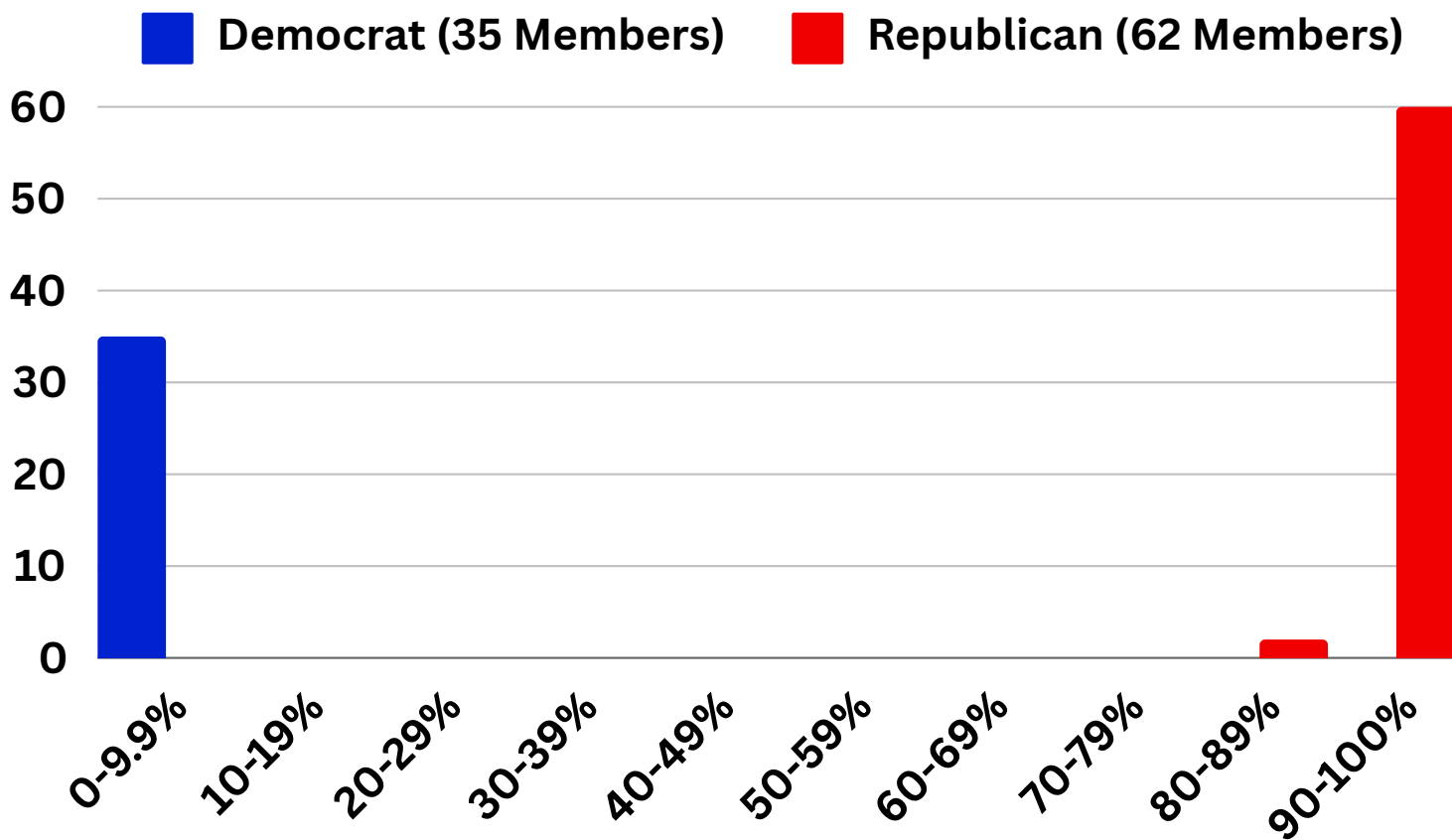

SJR 73 Codifying Voter ID Laws into Wisconsin's Constitution.

This resolution proposes a constitutional amendment that would require people to show their photo ID to election officials in order to vote. CPAC supports voter ID laws and supported this resolution. The Senate passed this resolution on November 7, 2023 by a vote of 21-10.

SJR 78 Banning Zuckerbucks in Wisconsin.

This resolution prohibits election officials from using private funds to administer public elections. CPAC supports efforts to improve election security and supported this resolution. The Senate passed this resolution on November 7, 2023 by a vote of 21-10.

SB 330 Expanding Wisconsin's School Choice Programs.

This bill raises the amount of money provided to parents under Wisconsin's school choice program from \$8,300 to \$9,499. While CPAC does not support Wisconsin's decision to raise burdens on taxpayers in order to fund this increase, it still supports school choice and supported this bill. The Senate passed this bill on June 14, 2023 by a vote of 24-9 and the bill later became law.

SB 436 Giving More Employment Opportunities to Youth.

This bill removes various permitting processes that made it more difficult for minors aged 14 or 15 to obtain employment. CPAC supports commonsense regulatory reform and supported this bill. The Senate passed this bill on October 17, 2023 by a vote of 21-11 but the bill had not become law as of the end of 2023.

AB 133 More Tax Credits for Wisconsin's Farmers.

This bill raises the monetary amount of tax credits that may be claimed by farmers per acre of eligible farmland that they preserve that are subject to "farmland preservation agreements." CPAC opposes the government's involvement in these initiatives and opposed this bill. The Senate passed this bill on November 14, 2023 by a vote of 31-2 and the bill later became law.

AB 141 Preventing the Creation of Product Bans in the Name of the Leftist Climate Agenda.

This bill prohibits local governments from restricting the use of particular devices based on the type of power source that they use. CPAC supports all forms of energy, believes that the government should not support one form of energy over another, and supported this bill. The Senate passed this bill on June 7, 2023 by a vote of 22-11 but Governor Evers vetoed the bill.

AB 142 Taking a Stand Against Bans on Gas-Powered Cars.

This bill prohibits the state government and municipalities from preventing the sale of vehicles because of the type of energy that they consume. CPAC supports all forms of energy, believes that the government should not favor one form of energy over another, and supported this bill. The Senate passed this bill on June 7, 2023 by a vote of 22-11 but Governor Evers vetoed the bill.



AB 146 Prohibiting Localities from Funding UBI Programs.

This bill prohibits municipalities from expending funds to pay for guaranteed income programs. CPAC opposes universal basic income programs, opposes the expansion of the welfare state, and supported this bill. The Senate passed this bill on October 17, 2023 by a vote of 22-10 but Governor Evers vetoed the bill.

AB 150 Reshaping the Unemployment Benefits System into the Reemployment Assistance Program.

This bill rebrands the unemployment benefits system as the reemployment assistance program. It also creates various work search requirements that one must fulfill in order to continue receiving financial assistance from the government under this program. CPAC supports efforts to ensure that government welfare benefits of this nature remain a temporary bridge between jobs and supported this bill. The Senate passed this bill on June 7, 2023 by a vote of 22-11 but Governor Evers vetoed the bill.

AB 152 Various Favorable Changes to the Unemployment Insurance System.

This bill requires the Department of Workforce Development to implement identity-proofing measures for unemployment insurance claimants. CPAC supports efforts to stop unemployment insurance fraud and supported this bill. The Senate passed this bill on June 7, 2023 by a vote of 22-11 but Governor Evers vetoed the bill.

AB 200 Increasing the Transparency of Wisconsin's Occupational Licensing Regime.

This bill requires the Department of Safety and Professional Services to include additional information about the licenses it doles out in its biennial report to the legislature. CPAC supports efforts to increase government transparency and supported this bill. The Senate passed this bill on June 14, 2023 by a vote of 22-11 and the bill later became law.

AB 465 No Radical Gender Surgeries for Minors in Wisconsin.

This bill prohibits physicians from performing gender surgeries on or prescribing hormone replacement therapy to minors. CPAC opposes the castration and mutilation of children and supported this bill. The House passed this bill on October 17, 2023 by a vote of 22-10 but Governor Evers vetoed the bill.

AB 494 Planning Ahead to Prevent Future Election Confusion.

This bill limits the number of people that may apply for and receive absentee ballots. For example, it states that the existence of a pandemic does not qualify a voter as "indefinitely confined." CPAC supports efforts to crack down on election fraud and supported this bill. The Senate passed this bill on November 14, 2023 by a vote of 22-11 but Governor Evers vetoed the bill.

SJR 73 Codifying Voter ID Laws into Wisconsin's Constitution.

This resolution proposes a constitutional amendment that would require people to show election officials a personal photo ID in order to vote. CPAC supports voter ID laws and supported this resolution. The Assembly passed this resolution on November 9, 2023 by a vote of 62-35.

SJR 87 Banning Zuckerbucks in Wisconsin.

This resolution prohibits election officials from using private funds to administer public elections. CPAC supports efforts to improve election security and supported this resolution. The Assembly passed this resolution on November 9, 2023 by a vote of 60-35.

SB 330 Expanding Wisconsin's School Choice Programs.

This bill raises the amount of money provided to parents under Wisconsin's school choice program from \$8,300 to \$9,499. While CPAC does not support Wisconsin's decision to raise burdens on taxpayers in order to fund this increase, it still supports school choice and supported this bill. The Assembly passed this bill on June 14, 2023 by a vote of 62-31 and the bill later became law.

AB 133 More Tax Credits for Wisconsin's Farmers.

This bill raises the monetary amount of tax credits that may be claimed by farmers per acre of eligible farmland that they preserve that are subject to "farmland preservation agreements." CPAC opposes the government's involvement in these initiatives and opposed this bill. The Assembly passed this bill on November 14, 2023 by a vote of 98-0 and the bill later became law.

AB 141 Preventing the Creation of Product Bans in the Name of the Leftist Climate Agenda.

This bill prohibits local governments from restricting the use of particular devices based on the type of power source that they use. CPAC supports all forms of energy, believes that the government should not support one form of energy over another, and supported this bill. The Assembly passed this bill on April 18, 2023 by a vote of 62-35 but Governor Evers vetoed the bill.

AB 142 Taking a Stand Against Bans on Gas-Powered Cars.

This bill prohibits the state government and municipalities from preventing the sale of vehicles because of the type of energy that they consume. CPAC supports all forms of energy, believes that the government should not favor one form of energy over another, and supported this bill. The Assembly passed this bill on April 18, 2023 by a vote of 63-35 but Governor Evers vetoed the bill.

AB 146 Prohibiting Localities from Funding UBI Programs.

This bill prohibits municipalities from expending funds to pay for guaranteed income programs. CPAC opposes universal basic income programs, opposes the expansion of the welfare state, and supported this bill. The Assembly passed this bill on April 25, 2023 by a vote of 60-34 but Governor Evers vetoed the bill.



AB 150 Reshaping the Unemployment Benefits System into the Reemployment Assistance Program.

This bill rebrands the unemployment benefits system as the reemployment assistance program. It also creates various work search requirements that one must fulfill in order to continue receiving financial assistance from the government under this program. CPAC supports efforts to ensure that government welfare benefits of this nature remain a temporary bridge between jobs and supported this bill. The Assembly passed this bill on April 25, 2023 by a vote of 60-35 but Governor Evers vetoed the bill.

AB 152 Various Favorable Changes to the Unemployment Insurance System.

This bill requires the Department of Workforce Development to implement identity-proofing measures for unemployment insurance claimants. CPAC supports efforts to stop unemployment insurance fraud and supported this bill. The Assembly passed this bill on April 25, 2023 by a vote of 59-35 but Governor Evers vetoed the bill.

AB 200 Increasing the Transparency of Wisconsin's Occupational Licensing Regime.

This bill requires the Department of Safety and Professional Services to include additional information about the licenses it doles out in its biennial report to the legislature. CPAC supports efforts to increase government transparency and supported this bill. The Assembly passed this bill on June 7, 2023 by a vote of 63-33 and the bill later became law.

AB 377 Protecting Girls' Sports in Wisconsin.

This bill requires that public school sports teams be designated for males, females, or both (coed). It then prohibits males from playing on the teams designated for females. CPAC supports efforts to create a safe and fair environment of play in school sports and supported this bill. The Assembly passed this bill on October 12, 2023 by a vote of 63-35 but the bill had not become law as of the end of 2023.

AB 465 No Radical Gender Surgeries for Minors in Wisconsin.

This bill prohibits physicians from performing gender surgeries on or prescribing hormone replacement therapy to minors. CPAC opposes the castration and mutilation of children and supported this bill. The Assembly passed this bill on October 12, 2023 by a vote of 63-35 but Governor Evers vetoed the bill.

AB 553 Cracking Down on Higher Education's Efforts to Ban Speech.

This bill prohibits public institutions of higher education from restricting non-violent speech and creating Orwellian "free speech zones." CPAC supports efforts to protect First Amendment freedoms and supported this bill. The Assembly passed this bill on November 7, 2023 by a vote of 62-36 but the bill had not become law as of the end of 2023.
